SST CARDS & IDENTITY VERIFICATION

Per the DOB, Course providers must verify an individual's identity and mailing address.

Before issuing an SST ID Card, Course Providers are required to verify the applicant's identity and mailing address using a point system or document calculator such as the one below based on the NYCID program.

The applicant's documents should total four (4) points in any combination as described below:

- 1. At least four (4) points of documents with:
 - At least three (3) points of documents proving identity
 - At least one (1) point for documents proving address
- 2. At least one (1) of the documents submitted must have a photo of the applicant.
